Dear Sir, At a well attended meeting of members of the Australian Workers' Union employed by the Commonwealth Carbide Co., at Electrona, in this State, a general discussion ensued regarding the action taken by the Commonwealth Federal Government, led by yourself, in connection with the Coal miners strike, and the consequent dislocation of Industry throughout Australia, after which a motion was carried unanimously approving of, and endorsing the action of your Government in its insistance that any settlement of this strike must be by constitutional methods, and applauding the Government for refusing to knuckle down to the demands of thecirresponsible Commo elements, who in our opinion, are responsible for the dislocation and disorder in many industries today. I would also like to mention that this attitude by our members at Electrona correctly sums up the opinion of workers in this State employed under Awards of the A.W.U. and serviced by this Union, and would like to also express my personal appreciation of the very fine work of your Government on behalf of workers and others during, and since the war years. I have to inform you that at the full annual meeting of the Bendigo Trades Hall Council held Wednesday 6th inst., the Management Committee's action in sending telegrams to yourself and other Ministers opposing the freezing of Union funds and intimating that the Bendigo Trades Hall Council was pledged to support the Miners in this strike, was endorsed by an overwhelming majority. I have also to inform you that if the report that delegates of 14 unions had written to you during last week-end, repudiating the Management Committee's action in sending these telegrams is correct, it was done without the knowledge of the unions they represent. Only two unions met last week between the publication of the contents of the telegrams and the libellous article which appeared in the Saturday July 2nd issue of the Bendigo Advertiser. Dear Mr. Matzkows,

I am in receipt of your letter of the 14th July in which is embodied copy of a resolution dealing with the coal strike.

Referring to your remarks concerning the imprisonment of certain Union officials for refusing to obey an Order of the Court, I attach copy of a statement issued by the Federal Attorney-General which clearly sets out the Government's attitude in regard to this matter.

With regard to the claims of the miners, Mr. McGirr and I have said, and I repeat it, that this matter can be settled only by the proper arbitral tribunal - that is the Coal Industry Tribunal - and not in any other way.

The Federal and State Governments are not expressing any opinion as to the merits or demerits of claims made by the Miners' Federation. What the Governments say is: whatever these disputes may be and whatever their merits, the decision upon them must be made by the body appointed for that purpose, and they cannot hope to enforce their claims by the law of the jungle.
